Tony Zhang, Co-Chief Investment Officer, Technology & Innovation, China Resources Capital

Dr. Zhang is a HK Permanent Resident, PRC. He has over 20 years' history in investment area, and more than 15 years' experience in senior management roles in private equity funds, domestic and crossborder M&A business.

Dr. Zhang was Business Director of M&A in the Strategic Management Department of China Resources Group. He also covered the real estate and financial sectors of the Group. Meanwhile, he also served as member of Investment Consulting Committee of China Resources Group and Deputy Director of the Investment Consulting Committee Office. Before joining China Resources Group, Dr. Zhang served as Assistant General Manager, Managing Director of M&A Department of Haitong Securities Co. Ltd (1st tier investment bank in China) and Investment Director of Global Mart Co., Ltd. (An PE fund focus on retail business investment in mainland China).

Dr. Zhang received his Ph.D. from the School of Management, Fudan University (China).

Nicholas Kwan, Director of Research of the Hong Kong Trade Development Council (HKTDC), a statutory body set up in 1966 to promote Hong Kong's external business. Nick's team includes about 30 economists and research professionals, providing macro-economic and business research support to the HKTDC and its various stakeholders.

Nick was formerly the Asia Chief Economist and Head of Research of Standard Chartered Bank. Earlier, Nick worked at the Hong Kong Monetary Authority (HKMA), specializing in macro-economic and policy research, and was the Asia Pacific Regional Chief Economist of Merrill Lynch. Nick is an economics graduate of the Chinese University of Hong Kong, with an MBA from Warwick University in the UK and was a Chartered Financial Analyst.





Conrad Tsang, Founder & Chairman, Strategic Year Holdings Limited

Mr Tsang has been in the private equity and venture capital industry for 20 years. Mr Tsang's industry experience includes: education and professional services, TMT, retail and consumer products, real estate, natural resources/mining, advanced manufacturing, automotive, healthcare, logistics, environmental products/services, energy and alternative energy, financial services etc. The companies he has been involved with include Noah Education Holdings Limited, Minsheng Education Group (1569.HK), Galloping Horse Media Group Limited, Kangda International Environmental Protection Holding Limited (6136.HK), Pansoft Group Limited, Ambow Education, Hidili Industry International Development Limited (1393.HK), Launch Tech Co Ltd (2488.HK), Great Wall Auto (2333.HK, 601633.CN), Nord Anglia Education, Kasca Education, China Mini-Storage. Prior to founding Strategic Year Holdings Limited, he spent 13 years at Baring Private Equity Asia ("Baring Asia"), where his last position was Managing Director. He was the Founding Partner of Baring Asia's Beijing office. Prior to that, he was with Merrill Lynch Asia Pacific doing equity research, focusing on media and retail sectors. In the 1990s, Mr Tsang began his career at Peregrine Investment Holdings, where he was involved with Asian fixed income sales and marketing.

Mr Tsang is currently President, Co-Chairman of PRC Committee and Co-Chairman of Real Assets Committee of the Hong Kong Venture Capital and Private Equity Association (HKVCA). Previously, he was Hong Kong Venture Capital and Private Equity Association's Chairman of the Board (2013-2015). Mr Tsang is a Member of the Mainland Business Advisory Committee of Hong Kong Trade Development Council (HKTDC). He is also the Co-Chairman of the Financial Services Committee of Hong Kong China Chamber of Commerce (HKCHCC). Prior to founding Strategic Year Holdings Limited, he was Senior Advisor, Asia with Apollo Education Group.

Mr Tsang obtained a Master's Degree in Management Studies at University of Oxford, United Kingdom; and a Bachelor's Degree in Electrical and Electronic Engineering (First Class Honors) at Imperial College of Science and Technology, London, United Kingdom.

JAFCO Asia is the wholly subsidiary of JAFCO Co Ltd, which is a listed financial company on the Tokyo Stock Exchange and has an AUM of over 2.4 billion (USD equivalent). Prior to joining JAFCO Asia, Mr. Chow was an Assistant Principal with Capital Z Asia Limited. Capital Z Asia was a private equity fund manager associated with CZI, a Fund-ofFunds investment manager that was headquartered in New York with an AUM of US\$3.8 billion, investing into hedge funds and private equity funds worldwide. Mr. Chow was based in Hong Kong then, responsible for making private equity direct investments in Thailand, Taiwan, Singapore and Indonesia, mainly in the media, consumer and technology sectors.

Mr. Chow is a CFA Charterholder and a CPA (Fellow member) of the Hong Kong Institute of Certified Public Accountants (HKICPA). He actively participates in the community by volunteering his service at various industry associations such as the HKVCA and CFA Society Hong Kong. He is also an independent director (INED) on the board of China LNG Group (0931.HK).
